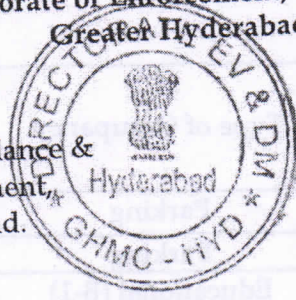

7. The builder is advised to obtain Occupancy Fire No Objection Certificate after completion of the building.
8. This order will be without any prejudice to take action against the Un-authorized construction if any made.


